**ORDER NO. T-31136 - 3-3-10** - Louisiana Public Service Commission vs Turkey Creek Trucking, Inc. (Haynesville, Louisiana). 5. Applicant agrees that no application for additional or expanded authority for the transportation of waste intrastate in the State of Louisiana shall be filed for a period of two (2) years from the date of the issuance of the common carrier certificate to the Applicant in this proceeding.

IT IS FURTHER ORDERED that the issuance of the certificate of public convenience and necessity is conditioned upon EFR Transport, LLC's full compliance with the laws of the State and the rules and regulations of the Commission.

**ORDER NO. T-31170 - 3-2-10**- Lafayette Steel Erector, Inc.
